Professional Employees Governance Board Meeting Minutes

1. Call to Order -

Michael B. called the meeting to order.

2. Acceptance of the Agenda

- o Michael B. called for any additions to New Business before the vote to accept.
- o John S. motion to approve agenda, Tracey I. second: agenda accepted.

3. Approval of Minutes - September 30, 2024

4. Reports of Officers and Standing Committees

- o Co-Chairs, Glen I. (east) and Michael B. (west) -
- Glen UFS plenary held last month. Attended with Brenda Andersen and John Shackelford. Reports to be shared at next month's university senate meeting.
- Michael will share out the statewide resolutions. One with particular significance to PEG: There is a proposal to increase the maximum period for term appointments for some lecturer positions to 3, 4, or 5 years. This may have relevance for professional appointments. 1) To allow for a longer initial term appointment period (>1 year, as is most common) but 2) these types of appointments also seem similar to appendix E appointments which is concerning.
- Michael: U Senate Exec Committee/CAS senate are looking to see how we (PEG) structure the professional senate to help inform their own restructuring plans.
